

Bergen Point Resolution

As reported in our last newsletter, LILWA President Andrew Andriola, Executive Director Linda Perlow and Secretary Dick Crescenzo met with Suffolk County Department of Public Works Commissioner Gil Andersen and members of his staff to discuss the early closings and cut in hours at the Bergen Point Scavenger Waste Facility.

The LILWA reps pled their case which included the negative effect it would have on servicing the homes and businesses as the Public Works Commissioner and staff listened intently. Other concerns included harm to the environment due to illegal dumping and the possible lay off of septic workers.

The county on the other hand had legitimate budgetary concerns they had to deal with and work out. In the end both sides agreed it was a dilemma and discussed other alternatives. Commissioner Andersen at the end of the meeting promised to take the problem and LILWA concerns to his superiors in an effort to find a resolution.

In the end a solution to the problem was attained and the Bergen Point hours have been restored thanks to the cooperation of government and private industry.



here in Suffolk County seventy percent of our homes have onsite systems. Suffolk efforts are not only focused on educating residents on proper servicing, maintenance and inspection but the development and promotion and funding of more efficient, innovative and upgraded onsite systems.

Due to our ecology, Long Island's surrounding waterways and vulnerable aquifer, LILWA has taken a proactive position on educating the Suffolk residents about the methods and importance of proper and timely inspection and servicing of septic systems. Regular septic care and inspection is vital to the health and protection of our valuable water resources.

Even smaller Municipalities including the membership of the East End Supervisors and Mayors Association are actively supporting an initiative with county and state officials to approve advanced onsite septic systems for their residents.

In celebration of SepticSmart Week a group of public officials and Suffolk residents led by County Executive, Steve Bellone, went on a tour of the many activities scheduled for this event. Among the many activities was a septic system inspection and servicing demonstration held at Alan Marvin's home in Nesconset. LILWA President, Andrew Andriola of Andriola Cesspool Service along with board members Joe Garbarino of L&J Cesspool Sewer & Drain Co and Dick Crescenzo of W.A.S.T.E. Inc. volunteered their services, time and equipment to make this demonstration possible.

Included in the tour was some of the sites chosen by Suffolk County for pilot onsite septic system upgrades in an effort to eliminate a greater percent of the nitrogen emitted by septic systems. According to County Executive Bellone "It's time to focus on issues that are and have driven water quality, and the issues that allow us to reverse the decline we've seen in our water quality".

Bellone has focused a great deal of his attention on our environment and the long term effects of our actions or inactions. He is encouraging a proactive position involving building awareness, educating homeowners about proper care and timely maintenance of their onsite septic systems. He is also working closely with LILWA in proposing changes to the licensing process. Some of these recommendations include required training and continuing education for many specialized septic services. The County

believes these proposed changes, additional training and accountability will increase consumer confidence.

The County Executive confirmed that a partnership Suffolk County has developed with the Long Island Liquid Waste Association is helping to improve relationships between the private sector and their customers in wastewater management.

Here's To Your Health



Linda Perlow As you may already know this is the beginning of the flu season. Last year's flu season was awful, most of us either came down with it or a family member or associate had a bad case. A bad season of the flu will cause adults to loose time from work and children to loose time from school, not to mention suffering through it.

Predicting how severe a flu season will be is not possible. Flu seasons are unpredictable in a

number of ways. While flu spreads every year, the timing, severity, and length of the season varies from one year to another. Most seasonal flu activity typically occur between October and May. Flu activity most commonly peaks in the U.S. between December and February.

Government officials urge every person over age 6 months be vaccinated, noting that it is the best guard against the bug. Despite that recommendation, less than half the U.S. population received a vaccination. Perhaps that had something to do with the worse then normal spread of the flu.

A few people should not get a flu shot without talking to their doctor first. These include people with an allergy to eggs, those who had a severe reaction to the vaccine in the past, some people who are ill, and children younger than 6 months.

People should also take sensible measurers in terms of staying home if they become ill, washing hands and covering their cough of course.

Dr. Tom Frieden, Director of the US Center for Disease Control and Prevention said "This is the beginning of the flu season, there's plenty of vaccine out there... Flu is a potentially serious illness."


According to Dr. Frieden there are 171 million doses of the flu vaccine being produced this season, with 40 million doses already distributed. In the past there were problems meeting demands.

The current vaccine, which has been modified to target a strain that caused millions of illness last year, Frieden stat-

ed, should be a good match against this season's influenza, but only time will tell.

If you are a person of high risk, be it up in age or have any serious health complications, also talk to your doctor about a pneumonia shot. A pneumonia shot is presently recommended five years apart max twice in a life time

It takes about 2 weeks for your body to make the antibodies that protect you. So the best time to get the shot is in October or November, before the flu season starts. But it can still help if you get the shot in December or later, since flu season often doesn't peak until February or even later. And flu is a risk year-round in the tropics. If you are planning travel to a tropical area, you need only one flu shot in a year.
