# The Island Lands State Funding

Open any national septic industry magazine and you will read about the coast-to-coast concerns about the environment, quality drinking water and nitrogen intrusion. Solution may differ from one geological area to another, however the one common denominator is the need for funding.

This past February New York state unveiled a \$75 million plan to contribute to the funding of replacing failing and outdated onsite septic systems. Out of the \$15 million which will be distributed the first year of the program \$10.025 will go to

Suffolk County, \$1 million to Nassau County and the balance upstate NY.

The New York State program will booster county and local legislative programs with essential additional funding. Also, as in most other septic programs home owner grants up to \$10,000 related to the cost of replacing systems with new innovative low nitrogen onsite systems.


### The Annual Judge Coleman **Memorial Scholarship fund**

It has been over 20 since Suffolk vears County adopted the Industrial. Residential Septic Tank/Sewer Drain Treatment, Bacte-Additive and Maintenance License Law back in 1995, affording consumers added protection and the industry a greater sense of professionalism. Prior to this, the septic industry was regulated under the all-inclusive Home Improvement

License Law which was adopted on July 19,1974.

As most of you know, to further protect the public health and water quality, Suffolk County's Legislature amended the Suffolk County Septic Code again effective June 23, 2016. Those septic companies applying for or renewing their license after June 23, 2016 were required to comply with the new regulations.

In an effort to address environmental and public safety concerns and develop a long lasting confidence in the septic industry and the labor force standards were developed. New and future developments in the sanitation industry will require a degree of ongoing education.

At this time 11 specialized endorsements were added under the Liquid Waste License. Specific training and/or experience for the particular service or services your company provides is required of any applicant applying for or renewing a Liquid Waste License as of the afore mentioned date.

The Long Island Liquid Waste Association (LILWA) onsite Septic Contractor Certification Program was approved by Suffolk County as an excepted training program for endorsements 1,2,3,4,5,6,7, and 9. Just a reminder, after 2 years of offering our certification program those who first availed themselves of it in 2016 are up for renewal. Any special news about your company, family or crew, let us know we would be glad to include it in our newsletter. It's always great to hear from our membership about their families staff and company news.



### A story from the past

# BUS SIZED FAT

Here in the states our septic treatment facilities may be concerned about pushing some grease through the grates, but across the pond in Surrey, England, just 30 miles south of London it was 15 tons of fat. This lump of lard was compared to the size of a

fat and wet wipes has been dubbed the "fatberg" in a press release from the utility. It took three nights the Thames Water company eight-man crew to clean up and remove the mound using shovels and waterjetting to dislodge the pulpy aggregation of cooking fat and flushed wet wipes, uncovered after residents in Kingston, Surrey complained about unflushable toilets. Together, the wipes and grease formed "a congealed wet mash" the size of a bus that smelled like "the worst wet dog you can ever think of."

According to Gordon Hailwood, supervisor at Thames Water "Given we've got the biggest sewers and this is the biggest fatberg we've encountered, we reckon it has to be the biggest such berg in British history."

In his press release, Hailwood urges homeowners and businesses to recognize what they're putting down drains so a blockage like the fatberg doesn't reoccur. He stresses the importance of not flushing wet wipes, an ongoing concern in our nation's sewers as well.

Meat fats like the white parts of bacon, or goose fat, or vegetable fats like Crisco, are solids at room temperature, when they're stored in a jar on the counter top. On a hot pan they turn runny and can be poured down a sink. But once they cool off, they turn solid and sticky once again. "Fats and wet wipes together are just a recipe for disaster," Craig Rance, press officer at Thames Water explained. The stuff may disappear down the drain, but down in the sewers, "a bit of fat will catch and a wet wipe will add on to it and it will catch and catch and catch."

The problem gets particularly sticky after food-related holidays, Rance said, and Thames Water gets a delayed Christmas bonus in a breakout of sewer blockages just around the New Year. Rance anticipates that his American colleagues face a similar problem just after Thanksgiving.

In March of 2017, at a press conference, County Executive Bellone unveiled "Suffolk County's Reclaim Our Water Septic Improvement Program" the next phase in his initiative.

After testing and approving advanced and innovative onsite septic systems for the homeowner, that meet the County's acceptable nitrogen levels. This next pilot phase will assist Suffolk homeowners with the financial cost of upgrading their aging cesspools and septic systems. According to County Executive Bellone "this program is a grant and financing initiative designed to make the purchase and installation of advanced septic systems affordable for the average homeowner".

Starting July1,2017 they would grant funding of \$11,000 per household allocates up to \$10,000 to cover cost of the unit and \$1,000 for installation.

"The total cost of the systems should range from \$14,350 to \$17,850 depending on site conditions and other factors" Bellone explained at a press conference. Low interest financing would be available covering up to \$10,000 of additional expenses. Applications and details for this program are available on the county web site.

Southampton also hit the ground running with their own program and new septic requirements.

### Long Island Sound 2017 Hypoxia Event Shortest in 24 Years

There is a need to document hypoxic conditions (low dissolved oxygen) in the Long Island Sound and its embayments, as defined in the Long Island Sound Study's Comprehensive Conservation and Management Plan. The Connecticut Department of Energy and Environmental Protection (CT DEEP) and the Interstate Environmental Commission (IEC) have been monitoring dissolved oxygen, as well as key water quality parameters relevant to hypoxia since 1991. The monitoring from 2017 showed the shortest hypoxic event. There has been a significant reduction of the hypoxic area in Long Island Sound, and compared to the previous 24 years, 2017 was the shortest event lasting 26 days and was well below the average of 53 days.

For the latter part of the twentieth century, the Sound has been subject to the effects of increased nutrient loading. Seasonal weather patterns, particularly during the summer months, exacerbate the effects of nutrient loading, causing hypoxia in the Sound. Hypoxia negatively impacts the water quality of the Sound, the ecosystem services and resources it provides, and the habitat that is home to many species.

In the early 1990's, the Environmental Protection Agency, Connecticut and New York State adopted a nitrogen reduction target of 58.5% by 2017 to reduce nitrogen in the Long Island Sound from levels recorded in the early 1990's. Hundreds of millions of dollars have been invested to reduce nitrogen by upgrading wastewater treatment plants that discharge nitrogen into local waterbodies, and as of 2016, New York and Connecticut nitrogen loads were below the Waste Load Allocations permitted by the plan, known as a Total Maximum Daily Load (TMDL).

### Suffolk and Nassau Counties Receive State Funding for Replacement of Aging Septic and Cesspools

The Clean Water Infrastructure Act of 2017 established the State Septic System Replacement Fund and allocated \$75 million to support a multi-year effort to replace aging septic systems in priority areas across New York State. Through a collaboration between the State Departments of Environmental Conservation and Health (DEC, DOH), and the Environmental Facilities Corporation (EFC), the State will support the new program in 31 counties with \$15 million during its first year. To guide the funding and maximize water quality improvements, DEC and DOH identified priority areas eligible to participate based on the presence of a sole-source aquifer used for drinking water, known water quality impairments linked to failing septic systems, and the ability for septic system upgrades to mitigate water quality impairments. Funding for each county was based on population density, as well as the proximity of septic systems to drinking water sources. Suffolk County is earmarked to receive \$10.025 million and Nassau County is to receive \$1 million. The remaining funds will be divided up between the 29 upstate counties.

### Town of Brookhaven Sewer Expansion Funding

Town of Brookhaven Supervisor and Long Island Regional Planning Council member, Ed Romaine announced that the Town has been awarded a \$30,000 New York State DEC Planning Grant to prepare an engineered plan, map and report for a sewer collection system to connect the Greater Bellport Hamlet Center to Suffolk County's Harrison Avenue Sewage Treatment Plant (STP). The plan, map and report will build upon the Greater Bellport STP Siting Options and Feasibility Study.

Brookhaven's 2014 Greater Bellport Land Use Plan presented the blueprint for a transit-oriented downtown supported by train and sanitary infrastructure. Brookhaven has aggressively pursued centralized wastewater treatment to protect the environment while stimulating economic development. The system design would have the potential to handle 75,000 gallons per day of wastewater from the Greater Bellport Hamlet Center, as well as an estimated 60,000 gallons per day from Bellport Village.

# Long Island Liquid Waste Association Certification 2018

The LILWA Certification program has been approved by Suffolk County to fulfill the qualifications for **endorse-ments 1,2,3,4,5,6,7 and 9**. It is a 4 credit hour open book test, designed to educate those applying for or renewing a Suffolk County Septic License. The course schedule is below and the fee is \$100 per person. Certification is scheduled for 4 times per year 2 sessions, morning and afternoon each date.

An application for the LILWA program and a free study guide can be down loaded at: www.lilwa.org. You will be supplied with a study guide at the session, however studying ahead of time will enable you to complete the session in a shorter period.

With larger tanks pump-outs are recommended on an as needed basis, based on a sludge test, and usually can extend pump-outs intervals to, 7+ years, lessoning the burden on your wallet.

#### • FULL ACCESS COVER FOR SERVICING

Higher quality effluent will also extend the life of your drain field minimizing costly repairs.

### • DISCHARGE PUMP INSIDE TREATMENT UNIT

When a discharge pump is required to pump effluent to a leach field we can conveniently locate the discharge pump inside of the AdvanTex tank. This means an additional pump tank is not required. The pump will be operated by the same control panel as the treatment unit This allows for a compact installation that is easy for the service provider to maintain.

A copy of the truck's registration & a photo showing the plate number and trucks dedicated use must be submitted when applying for or renewing a liquid waste license
