The Cost of Treatment

Citizens Campaign for the Environment, Group for the East End, Long Island Pine Barrens Society, and The Nature Conservancy have been working together for over a year to form this Long Island wide campaign and the Long Island Clean Water Partnership. They are now proposing Suffolk County initiate a property tax line dedicated to grants for nitrogen removing onsite septic systems, sewer expansions and improvements to sewage treatment plants.

They expect this ballot measure will raise \$70 million a year through water bills and/or property tax. There are other states and counties who choose to base this on the amount of water going into the residence. Water in and water out theory.

The environmental groups estimate the average yearly cost to home owners at \$75, however, the Suffolk Water Authority estimates it to be \$110 per year and possibly higher. Skeptical Suffolk County legislators and the Water Authority are concerned about the added cost to homeowners.



According to Newsday to get on the ballot, the water fee would need approval from the State Legislature. State lawmakers said they'd want to see support from the county legislature and Suffolk County Executive Steve Bellone.





This past February 11th
we held our first official expanded 8 Training Credit Hour (TCH)
Long Island Liquid
Waste Association
Certification session which I am proud to say without any major problems.

The most snags we encounter seem to come from license renewals and those who

fail to plan ahead. From my own personal experience it pays to foresee when you renew and how much time you need to comply. Continuing education is now a part of the license renewal process, sign up to complete your TCH at a convenient time for yourself. Know when your license expires and don't wait till the last minute to conform, as a Suffolk County Septic License holder this is your lively hood and your responsibility.

That being said, if a scheduling problem should arise call me at (631) 585-0448 so we can advise you on what to do.

The LILWA's Certification Program has been expanded to accommodate the Suffolk County Training Credit Hour (TCH) requirements introduced last July. For those of you applying for Endorsements 1,2,3,4,5,6, or 7 this will now fulfill the requirements of 8 TCH. This will provide installers applying for Endorsements 9,10, and/or11 with 8 of the required 12 TCH.

The program consists of a classroom presentation, down loadable study guide and an open book test. It is designed to educate those applying for or renewing a Suffolk County Septic License. Check out the 2019 LILWA Certification Program schedule in this edition of the LILWA news.

You probably already read in this issue of the LILWA News that the Judge Coleman Annual Scholarship Program is now in its second year, it is another benefit of belonging to LILWA. Don't forget to offer it to your family members, employees and their family members. I would like to thank those of you who have already so generously donated to this year's Scholarship Fund Raiser and remind those of you who want can go to www.lilwa.org to donate and/or apply for the scholarship.

For your knowledge the following pages contain the latest Suffolk County revised list as of February 25, 2019 of pilot programs and approved innovative and alternative onsite wastewater treatment systems (I/A OWTS).

* Note: PSD Category type determines loading rates allowed when sizing Pressurized Shallow Drainfields (PSD's) following pretreatment. Category 1 systems have been classified by The Department as meeting effluent standards less than or equal to 20 mg/L for both BOD and TSS and 5 mg/L for FOG. This classification is based on the average of the steady state data on file for a technology. This data will be updated every 6-months with provisional sample results from manufacturers and systems will be reclassified as the data warrants. A PSD Category of N/A indicates that the system does not meet the requirements for category 1 or 2 at this time.

Jeffrey Szabo, Chief Executive Officer of Suffolk County Water Authority was quoted in Newsday as stating "We believe nitrogen is an issue in surface water, in bays and estuaries. When it comes to a drinking water prospective, its not something that keeps me up at night." Obviously, there are differences in opinions here.

One of the main concerns about Suffolk County's war on nitrogen has been and still is funding.

SUFFOLK COUNTY DEPARTMENT OF HEALTH SERVICES LIST OF APPROVED INNOVATIVE AND ALTERNATIVE ONSITE WASTEWATER TREATMENT SYSTEMS (I/A OWTS)

All I/A OWTS technologies must be approved by the Department for use in Suffolk County as either an Experimental, Piloting, Demonstration, Provisional, or General Use system in order to be permitted for installation as a sewage disposal system in accordance with the "Standards for Approval of Plans and Construction for Sewage Disposal Systems for Single-Family Residences" and Standards for Approval of Plans and Construction for Sewage Disposal Systems for Other Than Single Family Residences". This list hereby specifies such approved I/A OWTS technologies in Suffolk County.

EXPERIMENTAL APPROVALS:

The following systems are approved for Experimental Use in Suffolk County, meaning that three (3) to five (5) systems of each technology may be installed on year-round properties. These systems will be sampled monthly for twelve (12) months and approval for Piloting will be granted if the total dataset of 75% of the experimental systems have a combined average of 19 mg/L or less TN

These systems will be sampled monthly for twelve (12) months and approved for Provisional Use if if the total dataset of 75% of the systems have a combined average of 19 mg/L or less TN.

PROVISIONAL USE APPROVALS:

The following systems are approved for Provisional Use in Suffolk County, meaning that there is no cap on the amount of systems that may be installed. However, the first twenty (20) year-round systems must be sampled by every other month for twenty-four (24) months and all other residential systems must be sampled every 12 months. Provisionally approved technologies may receive general use approval if the dataset of all of the 20 year round systems have a combined average of 19 mg/l or less TN.

<u>World Water Day</u>, an opportunity to reflect on and celebrate our relationship with water, the many ways it factors into our lives and why we must do more to protect this vital resource. The Long Island Nitrogen Action Plan (LINAP) Team is working on many fronts to target nitrogen pollution and develop a robust nitrogen reduction strategy for Long Island. Keep reading to learn what we have been doing lately.

The LINAP Team is working on:

- Groundwater monitoring
- Septic system replacement Suffolk and Nassau Counties incentive programs for homeowners and businesses
- Water reuse an interactive guide to help navigate the regulatory process and a map of wastewater treatment facilities and golf courses to encourage irrigation
- Fertilizer management DEC will soon publish recommendations based on the Fertilizer Workgroup discussions
- Long Island Drinking Water a study is underway that looks at the sustainability of Long Island's aquifer that is the source of drinking water for island residents.
- Wastewater treatment plant upgrades and sewer improvements in Nassau and Suffolk counties
- Expanding water quality monitoring efforts in the Western Bays of the South Shore Estuary Reserve Assessing the amount of nitrogen being discharged island wide into the ground and surface water

The LILWA Certification program has been approved by Suffolk County to fulfill the qualifications for **endorsements 1,2,3,4,5,6,7 and 9**. It is designed to educate those applying for or renewing a Suffolk County Septic License. The course schedule is below, and the fee is \$175 per person. It is an **8 Training Credit Hour (TCH)** program and is scheduled for 4 times per year.

The program consists of a classroom presentation, down loadable study guide and an open book test. It is designed to educate those applying for or renewing a Suffolk County Septic License.
